# **Privacy Policy**

J Rainford & Sons Limited understands that the information you trust us with is important to you and we are committed to protecting and respecting your privacy. This Policy explains how, when and why we collect personal information during the course of working with you, under what circumstances we may disclose your personal information to others and how we protect this data.

## WHAT INFORMATION WE COLLECT ABOUT YOU

We need information about you in order to conduct business with you and ensure that we engage in relevant business operations, products and services. This can include information about your business, some personal information about the individual(s) representing the business, other information that we collect as part of our business operations, and personal information we collect from other sources.

Data may include your name(s), the Company name, accounts address, delivery addresses, telephone numbers, email addresses and any relevant bank or other payment information to facilitate the transference of agreed funds in exchange for products and services.

We may also collect details regarding our operational interactions for health and safety, biosecurity and other safety related purposes. This may include site visits, location data, purpose of visit and other information that aids animal welfare and security.

### WHY WE USE THE INFORMATION ABOUT YOU

We collect your business and personal information in order to:

- Engage in consensual and legitimate business interactions
- Communicate with you any changes in products and services available that may be of legitimate interest
- Transfer funds in exchange for products and services
- Fulfil any legal obligation.

# YOUR INDIVIDUAL RIGHTS

- Right to be Informed You have the right to be informed about the collection of your data under GDPR guidelines.
- Right of Access You have the right to request a copy of the information that we
  hold about you. We will provide you with this information within one month of
  receiving your request. If the request is complex, we may extend the response time.
   We will inform you if this is the case and explain why.
- Right to Rectification We want to make sure that your personal information is
  accurate and up to date. You may ask us to correct, update or remove information
  you think is inaccurate or incomplete and we ask that you inform us promptly of any
  changes to your circumstances.
- Right to Erasure You may also ask us to erase your personal and business
  information from our systems, in certain circumstances. There are some specific
  circumstances where the right to erasure does not apply and we are permitted to
  hold your data. We will explain the reason for this at the time, should this occur.

- Right to Data Portability You may also ask us to move, or 'port', your personal
  information to another organisation electronically. We will only port personal
  information you have provided to us, that we have processed based on your consent
  or that has been processed automatically. We will port your personal information
  without charge and within one month where technically feasible.
- Right to Restricting Processing You have a right to request that we restrict the
  processing of your personal data in certain circumstances such as when accuracy is
  contested, if processing is unlawful, if data is no longer needed, pending a right to
  object action.
- Rights Relating to Automated Decision Making and Profiling You have the right to
  object to decisions made solely by automated means such as automated profiling.

### HOW WE STORE YOUR DATA

We will endeavour not to keep your personal information for longer than we have to for us to fulfil our obligations. Where it is not possible for us to delete your data, we will ensure the appropriate security and organisational measures are put in place to protect the use of your information. Customer data will be stored in our database software that is stored on our own secure servers. Data may be shared via email between the data controller and processor.

### **COMPLAINTS**

We work hard to ensure that your personal information is treated safely and securely. However, if you have a complaint, write to us using the details provided at the end of this Policy. You also have the right to complain to the Information Commissioner's Office.

## CHANGES TO OUR PRIVACY POLICY
